• Regulatory Committee deferred it's traditional meeting to attend the State Legislature Day. There is no meeting in May do to the MHHA Annual Conference. The next meeting will be June 21, 2012 at the MHHA office, following the Clinical Ops meeting.

### Rehab Ruth Benjamin

The Rehab Committee did not meet in April.

The Office of Regulatory Reinvention (ORR) released to the public its report to Governor Snyder containing 63 recommendations for improving Michigan's occupational licensing regulations. 18 occupations were recommended for deregulation (including Speech Pathologist) and 9 occupational boards were recommended for elimination (including the Board of Occupational Therapy and the Board of Speech Language Pathology). Hot topics:

- 1) CRT Separate Benefit for Medicare now has a bill introduced in the House <u>H.R. 4378</u>
  - a. Please contact your Congressmen and ask them to support this bill.
- 2) As of May 15<sup>th</sup> Medicaid is going to include the transit/tie down/D-loops in the base of the wheelchair. No reimbursement!!
- 3) Sometime in the near future Medicaid will be introducing a new MSA-1656 form.
  - a. Watch for the bulletin or email announcing this.
- No update on the RENTAL w/c's requiring the 1656 post 3 months of discharge. "They are reviewing this requirement".

#### Action items:

1) MHHA is working on a possible defense to issue #2 above.

#### Meetings:

 Medicaid - Repair labor payment policy. <u>Next</u> <u>teleconference to be scheduled sometime between</u> <u>June 4<sup>th</sup> and 8<sup>th</sup>.</u> Watch your email for the date and time.

Below is a recap of this workgroup;

- a. Several members met with MDCH staff via a conference call on Monday December 12<sup>th</sup>. The primary person from MDCH on the call was Lisa Trumbell, she is heading up this project. Members brought up several topics of concern regarding the current policy on repair labor payment. Some of the top concerns were;
  - i. Payment for repair labor on all items regardless if there is a HCPCS or fee schedule established.
  - ii. Establish a standardized labor rate manual for repair labor hours.
  - iii. Rental payment for "loaner" equipment during a repair episode.
  - iv. Service fee for "In-Home" service calls

◆ No Executive Director's Report as Barry Cargill was at the State Capitol for Legislative Day. ♦ Regulatory Updates: NGS and MDLARA scheduled to meet in May. \* • BCBSM to meet semi-annually; currently forwarding any questions. • Regulatory/QI Committee to meet in June, following Clinical Operations. +Sub-Committee Reports: IV Therapy/Infection Control completed revision of MHHA Infusion Policy/Procedure Manual utilizing the INS standards; sent to print and should be available in June. Psych Home Care - no-scheduled meetings at this time. Rehab Subcommittee had joint meeting last month; continue to work on therapy reassessments. Annual Conference - May 24 is Therapy Day, the agenda includes therapy topics. • New Business: State Legislative Day today following this meeting. Members gathered for orientation in Room 405 of the Capitol Building at 10:30 A.M. • Survey Report: One agency received TJC deemed survey with no citations but multiple suggestions "to assist the organization to take it to the next level." Second agency had TJC in December 2011 and then MDLARA in February. Findings: not tying up trash bag after wound care; missed HHA visit (only 1 and cited) new survey protocol "findings and not trends." Action plan and return visit went well. 

Agenda Additions: 1) cross check drop of RAP and OASIS submitted when policy reads lock in 7 days and submit within 30 days. To forward to Regulatory/QI Committee; 2) If F2F computerized then OK to use drop down boxes/State contacted. Is narrative necessary? What if developed in PCP office? To forward to NGS; 3) LSVT at MHHA Annual Conference in May. Interest in MHHA providing LSVT training at MHHA office for interested therapists in becoming certified. Forward to Ruth Benjamin to check interest at the Rehab Sub-Committee; 4) Reminder of Statewide Summit Reducing Avoidable Readmissions by Improving Care Transitions May 1, 2012 in Lansing; 5) HHCAPS - these questions have been shared with wstaff who then can focus on certain questions during their visit through the use of scripting. One agency developed a customer loyalty team; 6) From March 15<sup>th</sup> minutes, question to be submitted to MDLARA regarding comprehensive assessment within scope of physical therapy practice and COP to be able to assess the patient when another service is ordered, and if not then it nullifies the COP that states the therapist can admit; suggestion made to also, submit to NAHC attention Mary Carr or Mary St. Pierre. The next scheduled meeting will be held May 23, 2012 at the Annual MHHA Conference in Traverse City.

## Reimbursement Chris Kisell & Amy Gil

 The Reimbursement Committee met by teleconference in Okemos on April 18, 2012. Please join us for the next meeting on site at 9:30 on June 20<sup>th</sup>. • At the last meeting, there was continued discussion regarding the dual eligible population and the government's goals to realize cost savings by enhanced care coordination, simplification and alignment of Medicare and Medicaid rules. We talked about these impending changes and the impact it may have on agencies. 

The new BCBSM reimbursement rates and payments continue to be a challenge for providers. Agencies will need to submit a cost report through 12/31/2011. Those with a June fiscal year end can file either a 6 month (July to Dec) or an entire year (July to June). 

The next Benchmarking period in 01/01/12 - 03/31/12 and will be due by May 11<sup>th</sup>. The Committee still would like an increase in participation. The more agencies that take part, the more meaningful the data becomes. Abby will give results at Annual Conference, as well as the committee meeting. We look forward to your participation! 

 The Billing Committee meeting scheduled on April 26<sup>th</sup> was cancelled. The next meeting will be in June.
