## Regulatory Joan Taylor & Paula Stopjik

♦ Regulatory Committee met on October 18, 2012. Chris Garfield shared a recent federal court case which clarified that a failure to meet a Condition of Participation did not implicate a false claim as identified in the False Claims Act. This is good news for all Medicare providers who may at any place in time be out of compliance with a specific condition of participation. Chris also shared information on the Proposals on the ballot in November. From a legal perspective, most of the proposals are vague and therefore cause concern as they will then be added to the Michigan constitution. MHHA has taken an opposition position to Proposal 4 as it does not support the "agency model" for home service delivery. ♦ Pam Wozniak shared the handouts from CMS' survey protocols presentation which were rolled out in May 2011. This will be particularly valuable to agencies especially if the new intermediate sanctions for home health agencies are approved in the upcoming final rule. ♦ The group began work on an ICD-10 Assessment tool for home health providers. Key impact areas have been identified and the group will continue this work over then next several months. ♦ The next Regulatory Meeting is scheduled for November 15, 2012 after the Clinical Operations Committee at the MHHA Office. The HHPPS Final was issued November 2<sup>nd</sup>. And will be discussed in at the November meeting.

## **Public Policy**

#### WHY DO I OPPOSE PROPOSAL 4?

MHHA member, Joanne Sraj Sopko, RN, MSN, Owner/CEO of Alpha Omega Home Health in Elkton, Michigan offers her perspective on why she opposes Proposal 4 on the November 6, General Election Ballot. In an effort to share her perspective to appeal to the hearts of "regular voters" Joanne posted her thoughts on several online locations and offered to include it in the MHHA Bulletin. Here is what Joanne has to say about Proposal 4.

- 1. Aide's would be working without workman's comp insurance, if they hurt themselves, they would not get their medical bills paid, nor be reimbursed for the time off they might have to take.
- 2. The private individuals who hired the AIDE would have to pay the Aide's social security tax. It is quite common for such folks NOT to pay this tax. Social Security requires that a person work at least ten calendar quarters while paying into the Social Security system. These Aide's would either get no social security or a reduced social security check when they want to retire.
- 3. Another area of concern is that they would have background checks on hire, but what about drug testing on hire & randomly?
- 4. Aide's would be working without the supervision of an RN. This would not only make it impossible for them to renew their license, but have them making patient care decisions they aren't trained for. If a lawsuit should result, they wouldn't be covered by malpractice insurance.
- 5. Lastly, Proposal 4 would REQUIRE that Nurse Aides be union members. That should be for the Aides, not voters, to decide. If the Aides want to back out of the union, would we have to change the constitution AGAIN?

## **Clinical Operations**

#### Donna Kleinschmit & Sara Simonds

◆The Clinical Operations Committee met on October 18, 2012. Sara Simonds will serve as new Committee Co-chair. ◆ BCBSM update provided by Donna Kleinschmit. There is a meeting tentatively scheduled for 11/10/12. Rachel Aultman from Mid-Michigan Home Health will be attending. Please forward questions for the BCBSM group to the MHHA office. ♦ Subcommittees: IV/Infection control is continuing work on the updated Policy and Procedure manual. Psych Subcommittee has a focus on dementia and re-hospitalization related to behavioral issues. Rehab subcommittee is meeting next in November. ♦ New business Missouri Alliance Fall Risk assessment has been approved as a validated tool to use in the community setting. The rehab subcommittee members caution not to use this tool for all patients, as the TUG is perhaps more appropriate for patients who are able to participate in it. The suggestion is to use the MAHC-10 tool for non-ambulatory or cognitively impaired patients. There is a request for state associations to partner with the Missouri Alliance to do similar benchmarking as was done in the past with the Infection Control benchmarking project. With participation, there would be a discounted price for agencies. In the past, however, this was a very manually intensive project for the MHHA staff. • Discussion surrounding educational sessions and showcases which are upcoming. See the Education committee minutes. ◆ Survey reports - One agency had a CHAP survey. Issues with bag technique - staff using their own bag unknown to the agency - had no dirty/clean area differentiation. D/C summary process was an issue - did not like the agency process of hand delivering the summary as there was no "proof" of delivery. ♦ An agency had a report back from NGS regarding failing the re-validation process as the site visitor was unable to document any one was on the premises. Suggestion is to pursue this actively with office personnel and legal counsel to resolve ASAP. • Suggestion to add Medicaid liaison as a standing agenda item to the Regulatory update so that when issues do come up, there is a reminder. ♦ OASIS auditing process - discussion about individual processes. ◆ Proposed CHAP standards that just became final. No crosswalk is currently available from the old to the new. It should be coming out according to CHAP. ♦ Benchmarking software - discussion regarding use, benefits, etc. ◆ Scanning documents into the EMR - discussion as to the shredding of original documents.



## **Private Duty**

◆ The Private Duty Committee held a meeting on Tuesday October 16, 2012 in Okemos. We had our schedulers at the meeting and there was good conversation about best practices. There was discussion about Benchmarks for # of hours each scheduler can be expected to schedule on a weekly basis. Thanks to all who participated and shared thoughts and ideas of how we can better position ourselves in our businesses. • Licensing continues to be discussed and the fact that registry's need to be included. • Proposal 4-MHHA stance is vote no. It all sounds good but means that if you are taking care of a loved one at home and receiving so much as a stipend from Medicaid, you'll be considered a government employee and union dues will be deducted from those Medicaid payments. The funds acquired would be used to provide training to family caregivers (those not employed by an agency) and this is direct competition for the MHHA members. ♦ Auto No Fault for caregivers working in Private Duty for an agency and requirements of minimums of 100/300 in coverage. • The Education Committee continues to work with all of the committees for the Annual Conference, May 2013. ◆ The Public Policy Committee meets on the first Friday of every month and anyone who would like to attend are welcome. ♦ The next Private Duty meeting will be a teleconference on Tuesday November 20 at 12:30.

◆ The HME/Infusion Committee met via teleconference on October 15<sup>th,</sup> and the call was well attended. Amongst the topics discussed was Competitive Bidding. CB Round 2 remains perhaps the most pressing issue on the minds of Home Medical Equipment Providers. H.R. 6490, a bill that would replace competitive bidding with a market-pricing program (MPP), was introduced in September by Rep. Tom Price, R-Ga. The bill currently has 23 co-sponsors. MHHA Members are encouraged to contact their Congressmen and ask them to support H.R. 6490. We continue to work on issues relating to BCBSM Participation requirements. ◆ MHHA is in the process of scheduling a BCBS liaison meeting to clarify questions received from our members on this topic. ♦ Barry Cargill in October represented MHHA at the HME industry's largest trade show - "Med Trade" in Atlanta, Ga.
