• Summer is going way too fast. Michigan Home Care is gearing up for a full year of activity for members and the August Bulletin has the information you need to know. June is when most or our members renew membership but there are a few who have not renewed yet. Thank you to those members who renewed on-time as we appreciate your continued support. Your membership with Michigan Home Care could be one of the best investments you make in your agency. If your renewal is still sitting on the corner of your desk, please send it in. + Fighting Fraud and Abuse. Last week, the Centers for Medicare and Medicaid Services (CMS) announced a temporary and targeted moratorium on the approval of new home health agencies in the Miami and Chicago metropolitan areas. According to CMS, the goal of the moratoria is to fight fraud and safeguard taxpayer dollars, while ensuring patient access to care. Authority to impose such moratoria was included in the Affordable Care Act, and CMS is exercising this authority for the first time. There are areas of SE Michigan that continue to receive targeted enforcement by the Department of Justice and CMS's action in Chicago and Miami could happen to other areas including pockets of SE Michigan where several indictments have been issued in recent years. Michigan Home Care fully supports the action taken by CMS. We look forward to continue working with CMS and the Department of Justice as they continue targeting enforcement in the problem areas of Michigan. The Michigan Home Care Website has a link on the home page to report suspected fraud. • Talk with your federal and state legislators while they are in their home districts this summer. There is certainly no shortage of issues facing our member agencies and I encourage everyone to engage legislators in conversation about the issues impacting you and your agency. Every segment of the home care industry is facing regulatory and legislative threats and opportunities at both the federal and state level and the Michigan Home Care Public Policy Committee continues to recommend policy positions and monitors the issues. Here are some key issues that you can help with by talking with your elected officials:

♦ Rebasing Home Health Payments. Last month, CMS announced proposed changes to the Medicare home health prospective payment system (HHPPS) for 2014 incorporating rebasing along with changes in case mix weights. The CMS proposal would apply the full 3.5% rate cut. The results of such a cut would be an overall payment reduction of \$290 million based on projected spending in 2014. In related activity, Michigan Congressman Dave Camp released draft legislation that would seriously change the benefit structure of Medicare. Proposals included in the draft legislation range from increasing the Medicare Part B deductible for new enrollees to increasing income-related premiums under Parts B & D. Of greatest concern to Michigan Home Care is the suggested implementation of home health copay. Michigan Home Care remains committed to its opposition to shifting additional costs onto Medicare Home Health copayments. F2F. The Medicare home health face-toface (F2F) physician encounter requirements continue to be a major problem for home health agencies and their patients. Michigan Home Care and 37 home care agencies coming together from across the nation to gain support for a "Dear Colleague" letter to be sent to CMS. A copy of the draft letter was delivered to every member of the House of Representatives and will ask CMS for relief from the onerous F2F documentation requirements placed on home care agencies. The bipartisan Dear Colleague letter - sent by Representatives Tom Reed (R-NY), Paul Tonko (D-NY), Chris Smith (R-NJ), and Robert Andrews (D-NJ) - invites other members of the House to Exemption. Continued efforts by the US Department of Labor to eliminate the Companionship Exemption require our strong opposition. In Michigan, elimination of the federal exemption would then eliminate the exemption we currently have in Michigan for "live in" caregivers. ♦ Health Insurance Mandate. Senator Susan Collins (R-ME) introduced S. 1188, the Forty Hours is Full-Time Act, earlier this year. The bill aims to modify certain provisions in the Affordable Care Act (ACA) to define a "full-time employee" as someone who works forty hours a week. The ACA, as it's currently written, classifies "fulltime employees" as anyone who works thirty hours a week or more. S.1188 would allow employees to work more than 30 hours a week without triggering penalties under the ACA on the businesses that hire them. ♦ HME – Market Pricing Plan. Our Home Medical Equipment suppliers are suffering from the July 1, implementation of Round 2 Competitive Bidding. Michigan Home Care issued a supporting declaration in a lawsuit brought in federal court against CMS by AAHomecare. Competitive Bidding continues to be implemented so we must continue our efforts in support of HR 1717 to replace competitive bidding with the Market continues to be a hot issue here in Michigan and we are finally seeing some progress after a key State Senate Committee moved the plan to the full Senate for vote expected in late August or early September. Michigan Home Care continues to support expansion of Michigan Medicaid as well as an increase to the Medicaid provider rate. We need you to urge your state legislators to support Medicaid expansion.
 Again, I cannot emphasize enough how important it is to get to know your elected officials. They have the ability to impact your agency both positively and negatively and it's our job to educate them on the issues important to our agencies.

While most Michigan Home Care Committee's took a break in July, this month will get very busy again. Please continue reading this issue of the Bulletin and if you are not actively involved in your association, please make August the month you start.

IV/Infection Control

◆ The Infection Control/IV Subcommittee met on July 2th. The group has finally completed the review and revision of Michigan Association for Home Care IV Policy and Procedure Manual.  Michigan Association for Home Care's Private Duty Committee met June 18, 2013 via teleconference. Our next group meeting in August with the Home Care Association of America formerly the NPDA and other interested parties to discuss SB 71. ♦ A meeting was held July 16, 2013 to discuss Live-in care and potential definitions. Attorney Kim Pendrick from Kitch Drutchas Wagner Valitutti & Sherbrook spoke about the Fair Labor Standards Act and how it impacts Live-in caregiver wages.

Definition at the Federal level: An employee who performs companionship services in or about the private home of the person by whom he/she is employed is exempt from the FLSA's minimum wage and overtime requirements if all criteria of the exemption are met. When Michigan's minimum wage first exceeded the federal minimum wage, many employers who previously had FLSA exemptions for their employees were concerned because Michigan did not provide for the same exemptions. Michigan quickly amended the Michigan Minimum Wage Act to provide that it did not apply "to an employee who is exempt from the minimum wage requirements of the fair labor standards act of 1938, 29 USC 201 to 219."
 Currently Michigan Association for Home Care is continuing to work with community partners in the state on defining what a live-in caregiver means.

◆ Leadership for this committee is changing at this time and we hope to have this matter settled in August. ◆ The Committee is working on ICD-10 preparations and assistance to member agencies with this planning. ◆ A new issue was brought up regarding CMS' proposed changes to the provider enrollment requirements and expansion of revocation of billing services if a provider has a pattern or practice of billing for services that do not meet Medicare requirements. There is no definition of what this interpretation means. ◆ A pain assessment tool was distributed to members which is appropriate for use with patients diagnosed with dementia – the PAINAD. ◆Next meeting will be August 15 after Clinical Ops.
